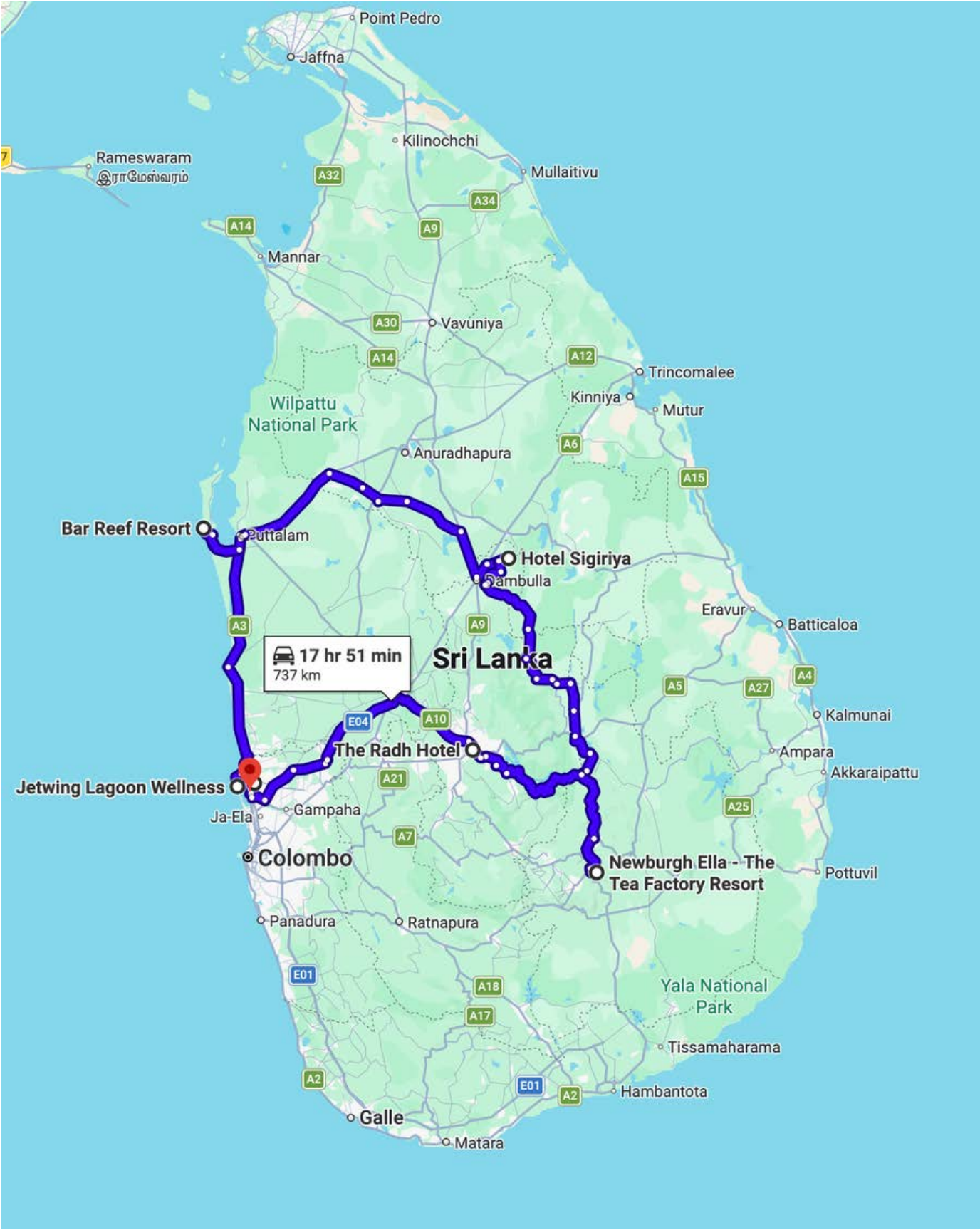

- All guests must make their tour package cost in full in US\$ to the relevant business account (Tour Operator) 60 days prior to arrival
- All guests must have their own return Air ticket for the destination (Sri Lanka)and return
- All guests must obtain a valid 30 day tourist Visa to Sri Lanka prior to arrival Please visit <http://www.eta.gov.lk>
- The above tour cost is included of 12 Day accommodation Food (full board) Transport from Airport back to Airport with a personal Driver and a Tour Guide
- All additional activities outside this arrangement will occur a fee by the Hotel or the activity organiser within the Hotel

Health Precautions and Vaccinations

Before embarking on their journey, guests must ensure they have received all necessary vaccinations and taken relevant health precautions. This includes obtaining any vaccines recommended or required for the specific country or region they plan to visit.

Identification of Pre-existing Medical Conditions

Guests are required to take proactive steps, such as consulting with medical professionals, to determine if they have any pre-existing medical conditions that could affect their ability to travel or participate in planned activities. This includes both known and unknown health issues that may arise during the trip.

Notification of Pre-existing Medical Conditions to Tour Operator

It is the responsibility of guests to inform Tour Operator about any pre-existing medical conditions they have or health issues that could impact their travel arrangements or activities before or at time of booking. This allows Tour Operator to make necessary accommodations or adjustments to ensure the safety and well-being of the guest during the trip. We may request a medical assessment from a qualify medical practitioner. This allows Tour Operator to gauge if we are able to accommodate your pre-existing condition. If your health issues are such that we cannot make accommodations, you will be refunded any price you have paid minus an administration fee of \$XXX. If you fail to inform us of any medical condition before booking and Tour Operator cannot make accommodations, then it will be considered a cancellation by the guest and all rules of that section (Section 4: Cancellations by Guests) shall apply.

Notification of New Medical Conditions to Tour Operator

It is the responsibility of the guests to inform Tour Operator about any new medical conditions they have been diagnosed with that may impact the usual booking of the treat. Tour Operator may also request a medical assessment by a medical professional so we can see how the condition may affect the booking.

If the guest requires assistance we cannot provide or does not provide the assessment when asked the booking will be cancelled as if it was cancelled by the guest, as such all rules in that section (Section 4: Cancellations by Guests) shall apply.

Compliance with Vaccination Requirements and Local Regulations

Guests must adhere to all vaccination requirements for entry into their destination country. Additionally, they are expected to comply with any local regulations or health measures imposed by authorities, which may include testing requirements or quarantine protocols. It is recommended that the guest be fully vaccinated against Covid-19 with a vaccine approved by the Therapeutic Goods Admissions. This is to reduce health risks to both you as well as others you may encounter on tour. Failure to comply with vaccination requirements or local regulations may result in guests being unable to continue with their planned travel arrangements. Unforeseen Circumstances During Travel

Additionally, Tour Operator will not be held responsible for any other losses incurred by the guest in connection with the booking, such as airfares or visa expenses, if they are prevented from commencing or continuing their trip under these circumstances. To mitigate financial risks associated with cancellations and disruptions, guests are strongly advised to purchase travel insurance promptly after paying their deposit.

Obligations & Liability

Tour Operator purchases transportation, accommodations, activities, and other services from independent suppliers within the country the trip is for. Tour Operator has no direct control over these independent suppliers and the guest acknowledges that Tour Operator is only responsible for choosing reliable and reputable suppliers to provide these services to you. When booking a trip the guest enters into a contract with Tour Operator, Tour Operator then purchases various products using the payment for the guest. When this happens the guest also enters a contract with the independent supplier who supplies these products such as travel or accommodation., Tour Operator will not be liable for any loss, damage, personal injury, or delay caused by independent suppliers. Any claims a guest may have must be taken up with the independent suppliers themselves.

All names provided to Tour Operator must be passport accurate as many of our suppliers and providers require passport accurate information. You also consent for us to share your passport identification with any suppliers who require it. A valid passport is also required to enter any foreign country so be sure to always keep it on you.
